Definition of "Obligation Acceleration" from ISDA Credit Event Definitions

Obligation Aceleration covers the situation, other than Failure to Pay, where the relevant obligation becom a default by the reference entity before the time when such obligation would otherwise have been due and builds in a minimum threshold which the relevant sum being accelerated must exceed before the Credit Ev Event forms a subset of that of Obligation Default. Thus if Obligation Default is specified as a Credit Event i transaction, this Credit Event will only be of relevance if the Default Requirement is lower than that in resp
